SEMA Welcome/Update

Thanks for SEMA coming in.

Stuart Gosswien – we consider the experts being the ones who use the lands locally, national level is Eric and myself who have access to the agencies and can pass on what is happening. One example is the land package that was put together by congress this last year. A win in California with OHV parks that had state designations and now have national protections. Utah gave land use designation that is more restrictive and roads were closed, because county supervisors were not in the loop. So this was hard to change this legislation. SEMA is asking for 3 or 4 things that are important, will be narrowing that down. This meeting allows us to work together.

Eric – looking forward we may not see many bills go through congress. A bill to take large acres in Colorado will pass the house and die in the senate. Utah is not allowing off road vehicles on the highway. If you are interested in being on the mailing list contact Eric Snyder, 202-792-7793,

Big Sarg – in Moab they got the business signatures, lost some areas because it was affecting the Arches. The anti-access did this in Moab and changed the entire state. The anti-access was able to do this because they are not fragmented and much better organized.

Eric – we could look at that if there is some type of framework to introduce a bill. Would be better to try to do it in another state and not in California.

Stuart - Outdoor Recreation Round Table – trying to create this in every state and have someone on staff. Federal legislation introduced, every three or four years the government uses an omnibus bill and bundles all the bills over the last several years and pass this bills. No matter how much we fight it there was still enough to pass the bills.

Big Sarg – the governor said the who community was behind it, but they were not. They even said the Utah 4 Wheel Drive Association was behind it and they were not. Land use is all political.
